Medical Marijuana Treatment Centers Applications: The Department of Health issued rules for Medical Marijuana Treatment Center (MMTC) license applications on September 19, 2017. Those rules can be found on the Office of Medical Marijuana Use webpage under the MMTC Applicants tab. Under that same tab you can also find applications, scorecards, and evaluation criteria related to MMTC applications.

Applicants may begin working on applications for submission. As stated in the rule, the Office of Medical Marijuana Use will publish in the Florida Administrative Register and post on our webpage when the office will begin accepting application and the deadline for receiving all applications.

Medical Marijuana Treatment Centers: Approved medical marijuana treatment centers are the <u>only</u> businesses allowed to grow, process, or sell medical marijuana in Florida. Each medical marijuana treatment center must receive authorization at three stages, (1) cultivation authorization, (2) processing authorization, and (3) dispensing authorization, prior to dispensing low-THC or medical marijuana. Currently, six of the 12 medical marijuana treatment centers have received dispensing authorization and are authorized to deliver statewide. Aside from patients or their caregivers, medical marijuana treatment center employees are the only individuals allowed to transport medical marijuana. Medical marijuana <u>cannot be mailed</u>.

The Medical Marijuana Use Registry: All orders for medical marijuana are recorded and dispensed via the Medical Marijuana Use Registry. The Medical Marijuana Use Registry is accessible online, with real time information to ordering physicians, law enforcement and medical marijuana treatment center staff. Patients and caregivers may also access the Medical Marijuana Use Registry to submit a Medical Marijuana Use Registry Identification Card application, and check the status of their application.

Restrictions for Use & Administration: Section 381.986, Florida Statutes, prohibits patients from smoking low-THC cannabis or medical marijuana. This means that patients <u>should not have whole flower</u> as part of their order. Florida law does not allow for home grow of low-THC cannabis or medical marijuana.
