



## MEDICAL MARIJUANA TREATMENT CENTER (MMTC)

### Usable Product and Marijuana Delivery Device Inventory and Unique Product ID

In accordance with Emergency Rule 64ER24-1(5)(a), “MMTC Seed-to-Sale System Integration,” an MMTC must identify and provide, together with its written integration plan, its current inventory of usable products and marijuana delivery devices (“inventory list”) to the Department of Health, Office of Medical Marijuana Use (OMMU). An MMTC must submit the inventory list **with** this form to the OMMU via email at [ommu\\_seedtosale@flhealth.gov](mailto:ommu_seedtosale@flhealth.gov).

The MMTC **must** submit the inventory list as an Excel (.xlsx) or CSV (.csv) file type with **only** the information listed on the following page. See “Inventory List: Required Information” for further instructions.

#### *How to Claim a Public Records Exemption*

If the MMTC intends to claim any exemption from public records disclosure under section 119.07, Florida Statutes, or any other exemption from public records disclosure provided by law for any part of its request, it must indicate on the request the specific sections for which it claims an exemption and the statutory basis for the exemption. The requestor shall submit a redacted copy of the request redacting **only** those items identified as exempt concurrent with the submission of the request for approval. Failure to provide a redacted copy of the request at the time of submission, or failure to identify and redact information claimed as trade secret may result in the release of all information in response to a public records request unless the information falls under another public records exemption.

The MMTC **must** submit the inventory list as an Excel (.xlsx) or CSV (.csv) file type with **only** the information listed below.

Bolded text denotes a column header. For example, if an MMTC intends to submit its inventory list as an Excel spreadsheet, the MMTC must title cell A1 as “MMTC Name,” cell B1 as “Product Type,” cell C1 as “Route of Administration,” et cetera.
